- Rapidly progressing
- MEDICAL FACILITY INQUIRIES: We've received several inquiries from prospects in these are as:
 - MICRO HOSPITAL: refers to hospitals with less than 10 beds
 - ➤ PERFORMANCE CENTER: multi-faceted therapy/fitness center looking to build a fourth facility possibly in RC to lease medical office space in addition to build in an outdoor/indoor turf field complex designed to train athletes of all ages
 - > SURGERY CENTER; Mr. Houk showed them 11 sites in RC and will continue to work with them to determine a site for their facility
 - > COMPOUND PHARMACY: this item was discussed at a previous meeting. They are holding until after the first of the year. We will continue to work with them
 - MEDICAL OFFICE BUILDING: we have received three inquiries, only one seemed concrete and tied to the performance center. Mr. Houk will attend a Hunt County Regional Medical Board meeting to make a presentation about Royse City in hopes of getting them to move toward the development of property they own off FM 2642.

❖ SPORTS FACILITY:

- Early interest on developing a youth sports facility in RC
- SYNAPTIC PEDIATRIC THERAPIES: Owners hope to be open and treating patients by the end of February
- ❖ CATALYST COMMERCIAL UPDATE: Mr. Claunch discussed the progress his firm is making toward discussions with retailers as discussed in previous meetings. Prospects include big box retailers, grocers, sit-down restaurants & automotive based retailers.
- **BYLAW REVISION COMMITTEE:** Revisions to the bylaws have not been addressed. We plan to recommit to the work after the new year.

CTE ADVISORY COMMMITTEE

- Mrs. Brown discussed the progress in creating a partnership with the school district, the RC Chamber of Commerce and the Texas Workforce Commission. By utilizing data from the various entities, we hope to determine the needs of our current business community and anticipate the needs of our future business community so that we may construct a workforce capable of meeting those needs.
- As a result of the initial meeting, Mrs. Brown (CDC), Mr. Gladu (CDC & business owner), Mrs. Stahl and Mrs. Burke (RC Chamber) and one to two members of the Texas Workforce Commission now serve on the district's CTE Advisory Committee. The Committee will meet quarterly
- In addition, the TWC is working with the district on a grant to update equipment for a current CTE offering that provides certification upon graduation.
- Mr. Gladu discussed the districts upcoming bond which will include a CTE wing. Mr. Gladu and Mrs. Burke served on the Bond Steering Committee.
- Lastly, the district agreed to the request to include elected officials and local colleges to gauge interest in serving on the CTE Advisory Committee.
