A. CALL TO ORDER

Announce the presence of a quorum.

At 7:01 A.M., Ms. Elder called the meeting to order. Mr. Pense gave the invocation.

B. DISCUSSION AND ACTION REGARDING MINUTES AND FINANCIAL UPDATE

I. MAIN STREET DIRECTOR REPORT: PAULA MORRIS

- 1. UPCOMING HOLIDAY EVENTS:
 - **a.** Christmas tree lighting tonight at 6.
 - **b.** Oudia Baley MS and RCHS bands will be there.
 - c. Christmas Parade will take place December 11, 2021.

LAMP POST PROJECT: New lamp posts are up. We hoped to have Christmas banners up but they are back ordered. Once we receive the arms for the lamps and know what size we are dealing with, we will order seasonal banners.

[Mr. Houk asked if there were any vacancies down town. Ms. Morris said, not at this time and indicated that she has a waiting list of businesses that are interested in being located down town.

Mr. Houk also asked Ms. Morris is she had received anything back from the Texas Historical Commission regarding renderings of the patio for the RCCDC newly acquired property on Elm Street (behind 3 businesses on Main Street). Ms. Morris said she had not heard from him but would follow up.]

J. DIRECTORS REPORT: CHARLES HOUK

- 1. VACANT LAND ON HIGHWAY 66 JUST EAST OF DOWNTOWN: Mr. Houk met with the new owner who is looking for a broker to help find users for a mixed-use concept. The project will consist of office/retail in the front with 2-4 plex residential in the back.
- 2. ROYSE CITY PHARMACY- The owner of the property listed in item J1 also has a contract on the pharmacy. Mr. Houk and Fire Marshall Tanner Dietz met him regarding fire code to help them determine what potential users could occupy by the space, however, fire code is determined by the type of user. The developer has not closed on the property. There are some cost prohibitive factors associated with this property such as parking, ingress, egress, and fire suppression.
- **3. ANDERSON CROSSING:** Mr. Houk will meet with the new owner next week to discuss master-planning the property.
- 4. DECEMBER MEETING: Our December meeting will take place at Denny's on December 14, 2021.
- 5. JOB FAIR: As an EDC, we felt it was important to assist in the sustainability of our businesses by helping to reduce or eliminate the staff shortages currently being experienced. RCCDC Assistant/Board Secretary Mrs. Brown along with Chamber directors Mrs. Stahl and Mrs. Burke, and Main Street Director Ms. Morris partnered together to host a job fair. The job fair will take place on December 3, 2021 at High Point Assembly of God from 1-4 p.m. An article will hit our social media page today regarding the event. We hope to pair employers with job seekers.
