#### **DIRECTOR'S REPORT: LARRY LOTT**

#### CHARLIE'S

While a permit has not been issued for Charlie's, dirt work has begun. Vertical construction can begin only after a permit is issued.

#### THE MEADOWS

The city has submitted a counter offer, which includes:

- A 35 acre entertainment venue
- 50% ad valorem tax rebate for 5 years
- 1/4-cent rebate from the city and the CDC sales tax until a combined total of \$5M is received from the sales tax and ad valorem tax rebated
- The city and CDC support the creation of a PID
- Support for Hunt County sales tax rebate

#### BUC-EE'S

Buc-ee's, along with several other projects, will be discussed at a P&Z meeting tonight. Currently, the 43 acres they have under contract is zoned agricultural. They have asked to rezone the portion that will be used for Buc-ee's as Planned Development, which would allow them to stray from our commercial standards to a degree in some areas, while exceeding those standards in other areas. The remaining acreage will be a regular commercial two (C2) zone. P&Z will also act on compliance with the Interstate 30 overlay district guidelines.

#### D.R. HORTON

Next Tuesday night the council will hear the creation of the Public Improvement District (PID) for D.R. Horton. Approval from council and creation of the PID are crucial; they trigger what needs to happen for Buc-ee's regarding the water CCN. We need the CCN rights from D.R. Horton to provide water for Buc-ee's. We look for things to move quickly once the PID is approved.

#### BONNER CARRINGTON APTS.

P&Z will also be looking at the preliminary plat, Interstate 30 Corridor overlay and offsite infrastructure for Bonner Carrington tonight. Bonner Carrington wants to use stucco for the building; our standards do not allow stucco. We require masonry. Bonner Carrington and their engineers will be at the meeting to discuss their offsite infrastructure needs; they will have to bring water from Walmart to their site and take it under I-30 and tie in to AA Granite on Circle Dr., which will require several Right Of Way (ROW) easements.

#### PARK RIDGE SUBDIVISION

P&Z will look at the master plat for Park Ridge as well. Park Ridge is located on F.M. 35 approximately one mile down the road from the high school, on the left. We have been working with them on several ROW easements.

#### CHICKEN EXPRESS

Mike Tatari, owner of Almo Plaza, is interested in having a Chicken Express franchise where Kentucky Fried Chicken used to be. One of the requirements of the family owned business is that the franchisee and operator is the same person. Mr. Tatari, who has several franchises, does not operate the facilities. Mr. Tatari has asked Mr. Lott, as the CDC director, to reach out to the Chicken Express family to express our interest in their facility.

#### URGENT CARE FACILITY

Mr. Tatari had two businesses, SNAP Fitness and Urgent Care, interested in leasing the offices previously leased by PCA at Almo Plaza. Due to some conflicts, Mr. Tatari has decided to lease the facility to SNAP Fitness, who looked at the space first.

#### MAYORS BREAKFAST-ROCKWALL

Mr. Lott, Mr. Alsabrook, and Mayor Nichol attended the Mayor's Breakfast in Rockwall. It was a good experience and well attended by all the elected officials of Rockwall and the cities within Rockwall County.

#### **SOUTHERN ROOTS**

Southern Roots made a presentation to the CDC board for an incentive grant on August 26, 2014. Although we agreed to grant the incentive and the business owner agreed to meet several of the requirements listed in the performance agreement, she never came to us to collect the grant money. We recently learned that due to circumstances in her personal life, she is going out of business. Clearly, we withdrew our grant.

#### **MAINSTREET DIRECTOR'S REPORT – Paula Morris**

Mr. Lott reported for Mrs. Morris who was unable to attend.

#### 141 E. MAIN STREET

This building has sold to a Kenyon Hill, a dentist in Rockwall, who also owns Arboleda's' building. She has leased the building to one of the owners of Fatted Calf (restaurant) in Rockwall. While it will not be another Fatted Calf, we are excited about the potential for a high quality restaurant.

#### THE FLOWER SHOP

The owner of the Flower Shop finally sold her building; the new business owner, Mr. Singh plans to open a specialty beer and wine store.
